Central-Top Properties Ltd. ("CTPL") is a wholly-owned subsidiary of JOF. JOF therefore has a deemed interest in the Units owned by CTPL and held by UOB Kay Hian Pte Ltd ("UOB Kay Hian"), as the depository agent of CTPL.

JOF was entitled to receive 17,572,213 Units from CTPL on 21 October 2008 as repayment of a loan from JOF to CTPL, after the release of such Units from a moratorium previously imposed on the Units. JOF had in turn declared a distribution of the 17,572,213 Units which it was entitled to receive to its shareholders on 21 October 2008 as a distribution of capital by JOF to its shareholders. The 17,572,213 Units were therefore transferred from CTPL directly to JOF's shareholders on 21 October 2008.

Accordingly, JOF's deemed interest in the Units owned by CTPL and held by UOB Kay Hian, as the depository agent of CTPL, had decreased by 17,572,213 Units from 52,716,640 Units to 35,144,427 Units pursuant to CTPL's transfer of 17,572,213 Units to JOF's shareholders.

Also, JOF's deemed interest in the Units owned by it had increased by 17,572,213 Units from 0 Units to 17,572,213 Units upon it becoming entitled to receive the 17,572,213 Units from CTPL, but has subsequently decreased by 17,572,213 Units from 17,572,213 Units to 0 Units upon its declaration of the distribution of the 17,572,213 Units to its shareholders.
