Berggruen Holdings Limited ("BHL") is the beneficial holder of more than 20.0% of the issued share capital of Japan High Yield Property Fund (II) Limited ("JHYP II"). MTL holds more than 50.0% of BHL. Accordingly, MTL has a deemed interest in the Units owned by BHL and held by Raffles Nominees (Pte) Ltd. ("Raffles Nominees"), as the depository agent of BHL, as well as a deemed interest in the Units owned by JHYP II and held by UOB Kay Hian Pte Ltd ("UOB Kay Hian"), as the depository agent of JHYP II. JHYP II has transferred 12,959,940 Units to its shareholders on 21 October 2008 as a distribution of capital, after the release of such Units from a moratorium previously imposed on the Units. As such, MTL's deemed interest in the Units owned by JHYP II and held by UOB Kay Hian, as the depository agent of JHYP II, has decreased by 12,959,940 Units from 38,879,819 Units to 25,919,879 Units.

Further, BHL is a shareholder of JHYP II and has received 5,222,229 Units from JHYP II pursuant to JHYP II's distribution of capital to its shareholders. Accordingly, MTL's deemed interest in the Units owned by BHL and held by Raffles Nominees, as the depository agent of BHL, has therefore increased by 5,222,229 Units from 3,151,000 Units to 8,373,229 Units.
