	# Please specify details	 Greenery Limited ("Greenery") and Starich are each indirectly owned by a trust in which Mr. Arnold Ip Tin Chee is one of the beneficiaries. Accordingly, Mr. Arnold Ip Tin Chee has a deemed interest in the Units owned by each of Greenery and Starich. Japan Opportunities Fund Limited ("JOF") was entitled to receive 17,572,213 Units from Central-Top Properties Ltd ("CTPL") on 17 December 2008 as repayment of a loan from JOF to CTPL, after the release of such Units from a moratorium previously imposed on the Units. JOF had in turn declared a distribution of the 17,572,213 Units which it was entitled to receive to its shareholders on 17 December 2008 as a distribution of capital by JOF to its shareholders. Greenery is one of the shareholders of JOF, and was entitled to a distribution in specie of 205,523 Units by JOF to Greenery on 17 December 2008 as a distribution of capital to the shareholders of JOF. Greenery had in turn instructed Starich Resources Limited ("Starich") on 17 December 2008 to hold on Greenery's behalf the 	
		205,523 Units which Greenery was entitled to receive from JOF.	

The 205,523 Units were therefore transferred by CTPL directly to Starich on 17 December 2008, and are held by UOB Kay Hian, as the depository agent of Starich.

Mr. Arnold Ip Tin Chee's deemed interest in the Units owned by Greenery and held by UOB Kay Hian, as the depository agent of Starich (which in turn holds the Units for Greenery), has increased by 205,523 Units from 205,523 Units to 411,046 Units upon JOF's declaration of the distribution of the 205,523 Units to Greenery.

Mr. Arnold Ip Tin Chee's deemed interest in the Units which Starich holds on behalf of Greenery, and which UOB Kay Hian holds for Starich, as the depository agent of Starich, has increased by 205,523 Units from 205,523 Units to 411,046 Units.

The overall increase in Mr. Arnold Ip Tin Chee's deemed interest in the Units is 205,523 Units as his deemed interest in the Units owned by Greenery and his deemed interest in the Units held by Starich on behalf of Greenery relate to the same Units.
