BHL therefore has a deemed interest in the Units owned by JHYP II and held by UOB Kay Hian Pte Ltd ("UOB Kay Hian"), as depository agent of JHYP II</p> <p>JHYP II has transferred 12,959,939 Units to its shareholders on 17 December 2008 as a distribution of capital, after the release of such Units from a moratorium previously imposed on the Units.
