VALUATION OF KINYACHO GRANDE

Japan Residential Assets Manager Limited (the "Manager"), the manager of Saizen Real Estate Investment Trust ("Saizen REIT") wishes to announce that a desktop valuation for the property Kinyacho Grande¹ ("KG") has been performed as at 31 December 2010 (the "Desktop Valuation").

KG's desktop valuation of JPY 419.0 million (S\$6.4 million²) represents a marginal decrease of 0.2% to its value of JPY 420.0 million (S\$6.5 million) based on the annual valuation performed as at 30 June 2010.

The Desktop Valuation was commissioned in connection with the divestment of KG³ as the previous valuation of KG was performed more than 6 months ago⁴. The Desktop Valuation was conducted by an independent valuer, namely, Success Solution Inc.

The valuation report is available for inspection at the Manager's registered office at 3 Anson Road, #34-01 Springleaf Tower, Singapore 079909, during business hours for three months from the date hereof.
