VALUATION OF CLUB HOUSE KIKUGAOKA

Japan Residential Assets Manager Limited (the "Manager"), the manager of Saizen Real Estate Investment Trust ("Saizen REIT") wishes to announce that a desktop valuation for the property Club House Kikugaoka ¹ ("CHK") has been performed as at 31 January 2011 (the "Desktop Valuation").

CHK's desktop valuation of JPY 230.0 million (S\$3.6 million²) represents a marginal decrease of 1.7% to its value of JPY 234.0 million (S\$3.6 million) based on the annual valuation performed as at 30 June 2010.

The Desktop Valuation was commissioned in connection with the divestment of CHK³ as the previous valuation of CHK was performed more than 6 months ago⁴. The Desktop Valuation was conducted by an independent valuer, KK Sakura Business Partners.

The valuation report is available for inspection at the Manager's registered office at 3 Anson Road, #34-01 Springleaf Tower, Singapore 079909, during business hours for three months from the date hereof.
