## **VALUATION OF ALTE HEIM ORIO**

Japan Residential Assets Manager Limited (the **"Manager"**), the manager of Saizen Real Estate Investment Trust (**"Saizen REIT"**) wishes to announce that desktop valuation for the property Alte Heim Orio<sup>1</sup> (**"AHO"**) has been performed as at 31 January 2011 (the **"Desktop Valuation"**).

AHO's desktop valuation of JPY 260.0 million (S\$4.0 million<sup>2</sup>) represents a decrease of 4.4% to its value of JPY 272.0 million (S\$4.1 million) based on the annual valuation performed as at 30 June 2010.

The Desktop Valuation was commissioned in connection with the divestment of AHO<sup>3</sup> as the previous valuation of AHO was performed more than 6 months ago<sup>4</sup>. The Desktop Valuation was conducted by an independent valuer, KK Sakura Business Partners.

The valuation report is available for inspection at the Manager's registered office at 3 Anson Road, #34-01 Springleaf Tower, Singapore 079909, during business hours for three months from the date hereof.
