COMPLETION OF DIVESTMENT OF RISE KUMADAI HOSPITAL II

Further to Saizen Real Estate Investment Trust's ("**Saizen REIT**") announcement on 7 June 2011, the Board of Directors of Japan Residential Assets Manager Limited, the manager of Saizen REIT (the "**Manager**"), is pleased to announce that the divestment of Rise Kumadai Hospital II was completed on 20 June 2011, and sale proceeds were applied towards the replenishment of Saizen REIT's cash reserves which had been previously utilised for the repayment of the loan of YK Shintoku in May 2011.

Rise Kumadai Hospital II's sale price of JPY 533,000,000 (S\$8.2 million¹) was paid in full on 20 June 2011.
