ASMCHGP is the general partner of ASM Connaught House Fund LP ("ASMCHF"). ASML is the beneficial holder of more than 20% of the voting shares of ASM Hudson River Fund ("ASMHRF"), ASM Asia Recovery Fund ("ASMARF") and other ASM Funds. ASMARF is the beneficial holder of more than 50% of the issued share capital of ASM Asia Recovery (Master) Fund ("ASMARMF"). ASML is also the fund manager of ASMCHF, ASMHRF and ASMARMF.
